**Declaration of physical fitness**  
 I, hereby declare that I have never suffered from any of the following which I understand may create, or lead to, a dangerous situation in flight: Blackouts from any cause, epilepsy, severe head injury, recurrent fainting or giddiness, high blood pressure, angina, coronary heart disease, insulin dependant diabetes, breathlessness whilst at rest, eye trouble, any nervous disorder or other relevant illness or injury. I will obtain a Doctor's certificate to DVLA Gp1 standard before flying solo and will renew at ages 45,50, 55, 60 and 65 and then annually thereafter. Instructors' certificates must be endorsed by a GP to DVLA Gp2 standard.

I undertake to make myself aware of the Club Health & Safety Policy Statement, displayed on the Club Health & Safety Board. I understand I should seek clarification from a Club Committee member if I have any queries on the Club Health & Safety Policy Statement.

I understand that if my flying fees account is still open six months after this membership has expired, the committee may, at its discretion, close that account.

I agree to abide by the rules and regulations of the Club and in particular I undertake:

- (a) Not to fly solo until I have been medically examined in accordance with AP 1269A or, if a civilian, signed a declaration of health endorsed by my GP in accordance with BGA regulations.
- (b) **To be responsible for ensuring that I do not fly solo without a valid medical certificate.**
- (c) Not to leave the club without paying all my fees.

**HEALTH AND SAFETY AT WORK - KEEVIL AIRFIELD**

The Bannerdown Gliding Club has an obligation under the HSW Act to ensure that, so far as is reasonably practical, contractors and visitors do not come to harm.

All visitors to the Club have a legal duty to take care and to avoid harming others by your actions or omissions; please therefore observe the following guidelines:

- This is an active airfield. Gliders, aeroplanes, or helicopters may approach from any direction and land or take off.
  - Comply with any instructions given to you by club officials or military personnel.
  - It is likely that your personnel and motor insurance's will not provide cover on the airfield. You may therefore be personally liable and be sued in connection with any accident, which you cause.
  - Stay in the notified areas. One is the clubhouse; the other will be at the glider launch point. Do not walk in front of gliders or powered aeroplanes.
  - Ask a club member to accompany you when travelling between the two areas.
  - Keep a good look out - above, to the front, side and behind you. Give way to gliders, aeroplanes and helicopters at all times when driving on the airfield.
  - Control your children and animals. You are responsible for their actions.
- Do not touch aeroplanes, gliders, launch equipment / machinery or cables.
